Introduction

Infants, defined as children under one year of age, accounted for a total of 226 deaths in North Carolina in 2022. The details below provide a data spotlight on the 210 finalized infant fatality cases as of July 2024. Numbers are subject to change. It is important to note that this report focuses exclusively on North Carolina residents and infant fatalities within the North Carolina Medical Examiner (ME) System.

Among the finalized infant fatality cases within the Medical Examiner (ME) System Jurisdiction, instances where the certifying pathologist was concerned with the infant's sleep environment or position or both as potential contributing risk factors to the fatality are detailed below. Infants in potentially compromising sleep spaces accounted for 64% of the 210 finalized infant fatalities during the year, totaling 135 deaths. Of those 135 sleep-related deaths, 29 were classified as accidental manner of death, while 106 were classified as undetermined manner of death. Please note the total number (9) of Sudden Infant Death Syndrome (SIDS) cases are excluded from the final counts as they are not considered sleep-related deaths.



Trends and Patterns in Infant Fatalities for 2022

Monthly Trends

In 2022, the highest number of infant fatalities occurred in October. In contrast, June experienced the lowest number of infant fatalities. This analysis highlights the significant monthly variations in infant mortality rates throughout the year.







Infant Fatalities by Month

Manner of Death

The figure below depicts infant fatalities across varying age milestones, highlighting the vulnerability of North Carolina's newborns. The curve of infant mortality illustrates the importance of prioritizing familial assistance and resources to parents and caregivers navigating the challenges of infant care. From providing continued education on safe sleep practices to accessible healthcare resources, bolstering support around families is a cornerstone in safeguarding the wellbeing of the most vulnerable.






Manner of Death of Child Fatalities in 2022




Figure 4. Total Sleep-related Infant Fatalities from 2012 to 2022

Sleep Environment

To provide a more detailed analysis of the potential sleep-related infant fatalities:

- Among the infant *accident/sleep-related* deaths, 21 of the 29 deaths were in a co-sleeping environment.
- Among the infant *accident/sleep-related* deaths, 8 of the 29 deaths were in other unsafe sleep environments such as extra items in the crib or an unsafe sleep location (in a car seat, on an adult sleep surface, etc.).
- Among the *undetermined/sleep-related* deaths, 70 of the 106 deaths were in a co-sleeping environment.
- Among the *undetermined/sleep-related* deaths, 36 of the 106 deaths were in other unsafe sleep environments such as extra items in the crib or an unsafe sleep location (in a car seat, on an adult sleep surface, etc.).

SIDS

SIDS deaths are not included in the metrics for unsafe sleep environments. However, the bar graph below compares co-sleeping, other unsafe physical sleep environments, and SIDS from 2015 to 2022.





Figure 5. Co-sleeping vs Other Unsafe Sleep Environments vs SIDS from 2015 to 2022
